This is a notice extending the period for submission of public comment on the draft Compliance Order on Consent (Draft Consent Order) for Los Alamos National Laboratory (LANL).

On March 30, 2016, the New Mexico Environment Department (NMED) issued an initial public notice for opportunity to submit public comment no later than May 16, 2016. Since issuance of that initial notice, NMED has received requests to extend the public comment period. The public comment period is being extended for an additional fifteen (15) day period. NMED will now receive public comment through **5:00 p.m. MDT, May 31, 2016.**
