Vermont Department of Public Service Announces December 7, 2020 Meeting of the Nuclear Decommissioning Citizens Advisory Panel. Recent NorthStar Vermont Yankee Decommissioning Activities to be Discussed; Election of Officers will be Held.

Montpelier, VT – The Vermont Nuclear Decommissioning Citizens Advisory Panel (VT NDCAP) will hold its fifth meeting of 2020 on Monday evening, December 7, 2020 from 6:00 PM to 8:45 PM. In accordance with changes to the Vermont Open Meeting Law in response to the ongoing COVID-19 pandemic, this meeting will be conducted as a Microsoft Teams webcast and teleconference.
